Subject to the exclusions and limitations set out below, Next Floor warrants that during the stipulated warranty period this product:

- will not wear through, where "wear through" means the complete loss of wear layer so that the printed pattern changes over a minimum of 3% of the total installation, and
- will be free from material manufacturing defects.

Subject to the exclusions and limitations set out below, the following remedies are available to you if the floor fails to perform according to this Limited Warranty:

- During the first year, Next Floor will at its option (i) repair the floor to conform to this Limited Warranty or (ii) furnish material of equal value and quality without charge for the affected area. Reasonable installation labor, not to exceed two dollars (\$2.00) per square foot of product, is covered by this Limited Warranty during the first year following installation if the flooring was professionally installed by a flooring contractor. There is no labor cost reimbursement for owner or D.I.Y. installation.
- During the second year, Next Floor will at its option (1) repair the floor to conform to this Limited Warranty or (ii) provide credit equal to 90% of the cost of material plus 90% of reasonable installation labor (calculated based on the maximum allowance and DIY installation provisions noted above).
- During the third year, Next Floor will at its option (1) repair the floor to conform to this Limited Warranty or (ii) provide credit equal to 80% of the cost of material 80% of reasonable installation labor (calculated based on the maximum allowance and DIY installation provisions noted above).
- After the third year, Next Floor will at its option (i) repair the floor to conform to this Limited Warranty or (ii) provide credit equal to the cost of Next Floor material only (no labor costs will be covered by this Limited Warranty after the third year) according to the following schedule:
  - During the fourth year: 70%; During the fifth year: 60%; During the sixth year: 50%; During the seventh year: 40%; During the ninth year: 30%; During the tenth year: 20%; During the rest of the term: 10%
